### NOTICE

The details of the said **ONLINE** examination (to be commenced from 1<sup>st</sup> October 2020) is given below:-

- 1) Students can download the question paper **half an hour (30 Minutes)** before the commencement of each examination inclusive both the halves. The college will share the question paper with all the student in their respective **email id's** provided by them to the college. 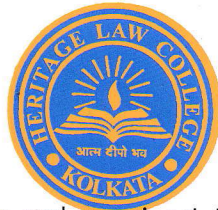
- 2) Students must use **black ball/gel pen** to write the answers. All answers submitted should be **handwritten** and not typed. The answers should be distinct, clear and readable by the examiner.
- 3) Each examination will be of **2 hours** duration. All Students shall upload their respective answer scripts within half an hour, immediately after finishing their examination.
- 4) Answers should not be lengthy. It should be to the point. Each page of the answer script should be numbered like (page 1, 2, 3.....)
- 5) All students must write their **(i) Calcutta University Roll Number & Registration Number (ii) College Roll No (iii) Name of the Examination (5years BA.LLB Examinations/ Semester) (iv) Date of the examination (v) Name of the Subject and Paper Number)** on the **first/front page** of the answer script. **University Roll No** must be written on each page of the answer script.

**Supplementary students, if any, must also mention their supplementary roll no and the subject/paper they are appearing for, at the front page of the answer script.**

- 7) Answer Script should be send in a single PDF File. The size of the PDF File should not exceed 15MB. The answer scripts should be uploaded in the following Email ID's.

- 8) Students of all semesters (1<sup>st</sup>, 3<sup>rd</sup>, 5<sup>th</sup>, 7<sup>th</sup>, 9<sup>th</sup>) are required to submit the hard copies of all the answer scripts which you have already uploaded in PDF format via email, by physically coming to college between **13<sup>th</sup> to 16<sup>th</sup> October from 11am – 4pm**. Please note that there should not be any discrepancy between the hard copy & the soft copy of the answer scripts.

Final Year (10<sup>th</sup> Semester) students must also submit the hard copy of their projects along with the answer scripts.
